Ordering implies acceptance of all General Terms and Conditions of Sales.

2 IMPORTANT

A Letter of Acknowledgment is drawn up by Miroir Brot including all details of the client's order. We ask our clients to kindly verify this Letter of Acknowledgment. This Letter of Acknowledgment must be returned to Miroir Brot including your company stamp, your signature and the mention "APPROVED". Once you have confirmed your agreement, no return will be accepted, unless agreed by Miroir Brot for major reasons involving our own responsibility.

3 PRICES

Our prices are free of tax. They are subject to modification without previous notice.

4 PRODUCT CHARACTERISTICS

Miroir Brot can modify, replace or cancel a product, without notice, compensation or indemnity. Weight, dimensions, photographs and drawings on our catalogues are indicative and cannot be guaranteed by contract.

5 INTELLECTUAL PROPERTY

The industrial and intellectual property of the commercial name, all logos, trademarks, patents and drawings, are Miroir Brot's exclusive property. The purchaser agrees not to alter, remove, destroy or hide any logo, mark or distinctive sign on any of our products.

6 TITLE RETENTION CLAUSE

The goods remain Miroir Brot's property until full payment of the invoice.

7 FREIGHT INSURANCE

ALL PRODUCTS MUST BE INSPECTED IMMEDIATELY UPON DELIVERY BY THE DEALER OR BY THE DEALER'S CUSTOMER IN THE CASE OF DROP SHIPMENTS. Claim must be made quickly to the freight forwarder and Miroir Brot must be advised promptly.

In case of sales conditions are in Ex Work, ex factory, the purchaser is responsible for all risks transportation.

8 CONDITIONS OF PAYMENT

Orders must be paid in full prior to shipping. All exceptions to above must have a written consent by Miroir Brot. In case of late payment, interest rates will be charged at a rate equivalent to One and half % (1.50 %) of the legal interest rate. This penalty will

be considered starting at the date of payment indicated on the invoice.

Failure to pay one invoice will result in immediate due payment of all pending invoices.

In case of contest, all actions shall be brought in the Tribunal de Commerce de Paris (France) that shall be considered as the only competent.

9 WARRANTY

Manufacturer Warranty period starts at receipt of the order by the customer for 12 (twelve) months. Miroir Brot warrants that the products delivered hereunder will be free from defect in material and workmanship and will be of the kind described in the order.

Damages that results from improper usage or careless handling shall not be covered by the warranty. In order to maintain the high quality of our product, a user guide is joined to each mirror. Any maintenance on the product (dismantling or modification) excludes warranty coverage.
